Open Enrollment for State Health Insurance Exchange

Columbia Valley Community Health offers assistance for area residents enrolling into the Exchange

Tuesday, November 11, 2014: **Wenatchee, WA:** Open Enrollment for the [Washington Health Benefit Exchange](#) begins this Saturday, November 15, 2014. [Columbia Valley Community Health](#) will be providing in-person assistance to residents of Chelan and Douglas counties throughout this open enrollment period, which will end February 15, 2015. During week days, this free service will be limited to patients of Columbia Valley Community Health (CVCH), however, CVCH will hold free Saturday enrollment events in December, January and February that will be open to the public.

Beginning Monday, November 17, in-person assistance will be available during regular clinic hours at the CVCH Wenatchee clinic, located at 600 Orondo Ave, and the CVCH Chelan clinic, located at 317 E. Johnson. These In-Person Asssisters, known as IPA's or navigators, will provide help with new enrollment applications, renewals, and processing insurance premium payments into the [Washington Healthplanfinder](#). IPA's are CVCH employees who have been trained to guide individuals through the enrollment process.

Marlen Mendez, Clinic Manager, is helping to facilitate open enrollment. She says even though this is the second open enrollment period for the state exchange, there is still confusion for applicants navigating the system.

"The stakes are higher this year with larger tax penalties for those who are eligible but choose not to enroll," Mendez says. "Insurance is about peace of mind, knowing that you are covered in emergencies and have access to routine preventative care visits to stay healthy. Columbia Valley Community Health and its staff members are here to provide guidance in the enrollment process – something that aligns with our mission of providing access to healthcare services with compassion and respect for all."
